2013 Lucas Oil Golf Scramble Benefiting Rauch, Inc. is a success!

Rauch's fifth annual golf scramble was a record setter! We're excited to share that the event generated approximately \$15,000 in net proceeds after expenses to provide programs and services supporting children and adults with disabilities in our community—a 19% increase in profits over the 2012 event. The event hosted 120 players, 30% more than 2012 and our highest attendance ever.
